Purpose and Scope:

Provides guidance for establishing a method to share information with the committee and the states emergency management coordinators. As the Iowa Emergency Management Association (IEMA) has established districts and holds regular district meetings. Using these meetings as a communication avenue is advantages to both organizations.

Emergency Management Districts:

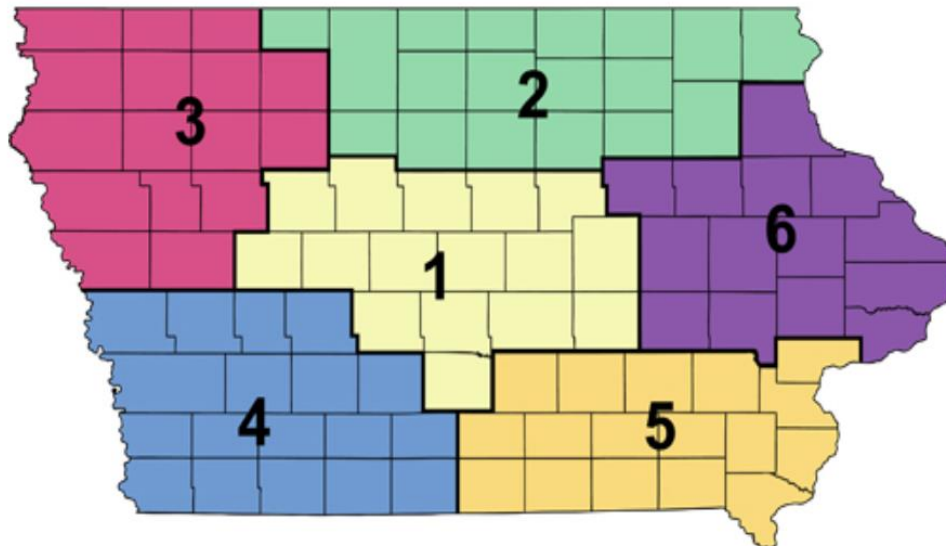


Figure 1 Map of Emergency Management Districts

The IEMA has divided the state into six emergency management planning districts, which are geographically the same as Iowa HSEMD's homeland security planning regions. Figure 1 is a map of the districts.

A point of contact will be established within each district. It will be encouraged that the point of contact be a member of the CERT Support Committee.

Communications of interest for the various emergency management coordinators will sent to the various district liaisons. The information will then be distributed within the district by the liaison. This method will be used to reduce email volume to the individual coordinators. Additional as much of the communications may be questions, this method fosters discussion at the IEMA district level meetings.
