Understanding How to Serve Individuals with Dementia During Disasters

Hayl Bergeland

Haylee Bergeland, or "Hayl", is the Education Coordinator for the Alzheimer's Disease and Related Dementias Program within the Iowa Department of Health and Human Services (Public Health Division) and an instructor for Kansas State University's Center on Aging (global campus). She owns GLADYS, IIc, a consulting business that provides aging in-place consultations, end-of-life care, and support for individuals living with dementia and their caregivers. Hayl has a Master of Science (MS) degree in Gerontology and a Bachelor of Science (BS) degree in Psychology.
